

## Space Jam Tune Tokens Official Rules

**NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING A SWEEPSTAKES PRIZE.**

**ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND PARTICIPANTS/ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

Overview: Space Jam Tune Tokens (the "Promotion") consists of a rewards program (the "Reward Program") and a sweepstakes (the "Sweepstakes"). The Sweepstakes is only available to shoppers at Walmart unless you enter the Sweepstakes through the alternative method of entry described below. The Rewards Program encourages you to make Qualifying Purchases, visit the Website and upload receipts to show proof of purchase. Once your purchases are validated and when you qualify, you will have the option to choose which Reward Prize you would like to redeem. If you'd like to participate in the Sweepstakes, there are two (2) methods of entry. *Walmart Shoppers*: Method 5(a)(I) requires that you upload receipts showing proof of purchases made at Walmart or Walmart.com. Follow the instructions to upload your receipt(s), just as you would if you're participating in the Rewards Program. Once you've provided proof of three (3) Qualifying Purchases at Walmart or Walmart.com, you will automatically accrue one (1) sweepstakes entry, up to ten (10) total Sweepstakes entries. If you are not a Walmart shopper, you can enter via Method 5(a)(II), No Purchase Necessary, in order to receive up to ten (10) total Sweepstakes entries.

**1. Eligibility:** The Promotion is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) United States (including the District of Columbia), and who are at least eighteen (18) years of age or older at the time of entry/participation. Employees, officers and directors of General Mills Sales, Inc. ("Sponsor"), ShopperWorks, Merkle Inc. ("Administrator"), Walmart, Inc., Warner Bros., Entertainment, Inc., and each of their respective parent and affiliate companies, advertising and promotion agencies and distributors and other prize suppliers (collectively, "Promotion Entities"), as well as the immediate family (i.e., spouse, parents, siblings children and grandchildren) and/or those living in the same household members of each such employee, officer and director (whether legally related or not) are not eligible to enter or earn a reward or win a prize in this Promotion. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Participation constitutes participant/entrant's full and unconditional agreement to these Official Rules. Sponsor's and Administrator's decisions are final and binding in all matters related to the Promotion. Receiving a Reward Prize/winning a Sweepstakes prize is contingent upon fulfilling all requirements set forth herein.

**2. Sponsor:** General Mills Sales, Inc., One General Mills Blvd., Minneapolis, MN 55426. **Administrator:** Merkle Inc., 3000 Town Center, Suite 2100, Southfield, MI 48075.

**3. Timing:** The Promotion begins at 7:00 a.m. Eastern Time ("ET") on May 31, 2021 and ends at 11:59 p.m. ET on October 31, 2021 (the "Promotion Period").

The Reward Program consists of two (2) phases (each, a "Phase"), as set forth below.

"Purchase" - Make a Qualifying Purchase	May 31, 2021	September 30, 2021
"Redemption" - Complete Redemption/Select Reward on Website	May 31, 2021	October 31, 2021

Administrator's computer is the official time-keeping device for the Promotion.

**4. Rewards Program:** This Section outlines which products qualify, how to upload a receipt (Section 4(a)) as well as how to claim a Reward Prize and which Reward Prize options you will be able to choose between (Section 4(b)).

**a) How to Make a Qualifying Purchase, Register/Create an Account and Upload Receipt(s)/Proof of Purchase:**

During the Purchase Phase, make a purchase(s) of qualifying products (see list of qualifying products in Appendix A) at any participating retail store location or online website (each qualifying product purchase herein referred to as a "Qualifying Purchase"). **Be sure to keep your receipt.**

All participants must register and create an account, by visiting [www.GeneralMillsTokens.com](http://www.GeneralMillsTokens.com) (the "Website"), during the Purchase Phase, and following the links and instructions to complete the registration form. Limit: You may create one (1) account. Multiple participants are not permitted to share the same email address. Any attempt by any participant to create or obtain more than one (1) account by using multiple/different email addresses, identities, registrations and logins, fraudulent email or IP addresses, or any other methods will void that participant's account. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant provided that person meets the eligibility requirements to participate in the Reward Program. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each participant may be required to show proof of being the authorized account holder.

Then, upload an image of your receipt(s) showing your Qualifying Purchase(s). The image must be clear and legible, include the purchase date/timestamp on your receipt, show the Qualifying Purchase(s), including the price of the Qualifying Purchase(s) you purchased on your receipt, as well as total amount of money spent on the receipt. Multiple Qualifying Purchases can be made on a single receipt. Each receipt may only be uploaded once. Upon validation of your uploaded receipt(s), you will receive one (1) "Tune Token" on a virtual token card for each Qualifying Purchase made on the receipt(s). There is no limit on the number of receipts you may upload in a calendar day.

**b) How to Claim a Reward Prize:** Once you have earned three (3) Tune Tokens, during the Redemption Phase, you will have the option to choose between one (1) of the following two (2) Reward Prize choices OR choose to continue to make additional Qualifying Purchases toward Tier 2.

**Tier 1 Reward Prize options:**

Option 1: One (1) phone ring. Approximate Retail Value ("ARV"): \$10.00.

Option 2: One (1) magnet set. ARV: \$5.00.

Once you earn an additional five (5) Tune Tokens (a total of eight (8) Tune Tokens), during the Redemption Phase, you will have the option to choose between one (1) of the following two (2) Reward Prize choices OR choose to continue to make additional Qualifying Purchases toward Tier 3.

**Tier 2 Reward Prize options:**

Option 1: One (1) "Tune Squad" towel. ARV: \$15.00.

Option 2: One (1) water bottle. ARV: \$12.00.

Once you earn an additional four (4) Tune Tokens (a total of twelve (12) Tune Tokens), during the Redemption Phase, you will have the option to choose between one (1) of the following two (2) Reward Prize choices.

**Tier 3 Reward Prize options:**

Option 1: One (1) inflatable game. ARV: \$50.00.

Option 2: One (1) pair of headphones. ARV: \$30.00. The actual value of electronic prizes is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed.

**Your selection of Reward Prize(s) must occur during the Redemption Phase; in other words, you must select your Reward Prize(s) on or before October 31, 2021. Once your Reward Prize selection has been submitted, the number of Tune Tokens associated with your selected Reward Prize will be subtracted from the total number of Tune Tokens associated with your account. If you have enough Tune Tokens, you may select and redeem more than one (1) Reward Prize at the same time during the Redemption Phase.**

**There may be limited quantities of any given Reward Prize. If a listed Reward Prize runs out, Sponsor will determine a substitute of equal or greater value.**

If you fail to follow the above instructions or if you upload an invalid receipt, you will not receive a Tune Token.

If, at the end of the Redemption Period, you have earned Tune Tokens but not redeemed them, such Tune Tokens will be forfeited. Tune Tokens have no cash or monetary value during or after the Promotion Period.

Pooling of Tune Tokens by multiple individuals is not permitted.

Limit: Each participant may show proof of up to sixty (60) Qualifying Purchases to receive up five (5) Reward Prizes per household during the Program Period. Any attempt by any Reward Program participant to obtain more than the stated number of Reward Prize by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Reward Program participant's Reward Prize and that Reward Program participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Reward Prizes should be fulfilled approximately 8-10 weeks after the conclusion of the Promotion Period, but no later than January 15, 2022. Reward Prizes may not be returned.

**5. Sweepstakes [Available at Walmart Only]:** This Section outlines how to enter the Sweepstakes (Section 5(a)), details on when the random Sweepstakes drawing will occur and winner requirements to order claim his/her/their prize (Section 5(b)) as well as the Sweepstakes prize details (Section 5(c)).

**a. How to Enter the Sweepstakes: There are two (2) ways to enter:**

- I. Make Qualifying Purchases at Walmart or Walmart.com: During the Promotion Period, following the links and instructions outlined in Section 4(a) above to visit the Website, register or log in and upload receipts showing proof of your Qualifying Purchases at Walmart or Walmart.com. **In order to qualify for the Sweepstakes and participate in this method of entry, each Qualifying Purchase must be made at Walmart.** Once you receive three (3) Tune Tokens from showing proof of Qualifying Purchases made at Walmart or Walmart.com, you automatically will receive one (1) Sweepstakes entry.

- II. Mail-in Alternate Method: To enter without making a Qualifying Purchase(s) at Walmart or Walmart.com, during the Promotion Period, hand print your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Space Jam Tune Tokens," c/o Merkle Inc., P.O. Box 5010, Department 848101, Kalamazoo, MI 49003-5010. You will receive one (1) entry into the Sweepstakes. Limit: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by November 1, 2021 and received by November 8, 2021. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: You may receive up to ten (10) Sweepstakes entries during the Promotion Period, regardless of method or combination of methods of entry. Multiple Sweepstakes entrants are not permitted to share the same email address. Any attempt by any Sweepstakes entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, fraudulent email or IP addresses or any other methods will void that Sweepstakes entrant's entries and that Sweepstakes entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the Sweepstakes entrant provided that person meets the eligibility requirements to participate in the Sweepstakes. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder. If a dispute cannot be resolved to the Administrator's satisfaction, the entry will be deemed ineligible. The submission of an entry is solely the responsibility of the entrant. Proof of sending (such as an automated computer receipt confirming delivery of email or "thanks for entering" message does not constitute proof of actual receipt by Administrator of an entry for purposes of this Sweepstakes. Only eligible entries actually received by Administrator's server before the end of the Promotion Period will be included in the Sweepstakes.

- b. **Sweepstakes Prize Drawing and Winner Requirements**: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the Promotion Period, on or around November 11, 2021. The potential winners will be notified by email, mail or phone. Each potential "Movie Night Prize Bundle" winner (or parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim his/her/their prize. If a potential winner of any prize cannot be contacted, fails to sign and return the Declaration or provide any other requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits his/her/their prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason or forfeits the prize, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Sweepstakes Prizes will be awarded 8-10 weeks after the conclusion of the Promotion Period.

- c. **Sweepstakes Prizes/Odds:** THIRTY (30) "MOVIE NIGHT PRIZE BUNDLE" PRIZES: Each winner of the Sweepstakes will receive one (1) "At Home Movie Experience" prize package consisting of the following prizes: one (1) projector with a portable screen; one (1) Polaroid® OneStep Plus Camera and two (2) packs of film; one (1) popcorn maker; five (5) popcorn cups; one (1) bean bag chair; one (1) cuddle pillow; one (1) silk touch throw; one (1) stretchy Taz toy and one (1) Marvin the Martian toy. ARV: \$1,000.00. The actual value of electronic prizes is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received during the Promotion Period. Limit: one (1) prize per person. Total ARV of all prizes awarded in the Sweepstakes: \$30,000.00.

**6. Release:** By entering the Promotion, each participant agrees to indemnify, defend, release and hold harmless Promotion Entities, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against losses, damages, rights, claim, or cause of action of any kind arising, in whole or in part, directly or indirectly, out of your participation in the Promotion or resulting directly or indirectly, from your acceptance, possession, use, or misuse of any prize awarded in connection with the Promotion, including, without limitation, personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

**7. Publicity:** Except where prohibited by law, participation in the Promotion constitutes each Sweepstakes winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, statements, social media posts, username, opinions and/or hometown and state for promotional purposes in any media and manner, worldwide, without further payment, notice or consideration.

**8. General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Promotion, if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion, or any event or cause beyond Sponsor's control (e.g., events such as natural calamities, national emergencies, wide spread illnesses, declarations of war, acts of God, acts of terrorism) interferes with any aspect of the Promotion, including, but not limited to, fulfillment of the prize(s), as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance and may modify the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Sponsor reserves the right, at its sole discretion, to disqualify any individual found to be: (a) violating the Official Rules; or (b) violating the terms of service, conditions of use and/or general rules or guidelines of any Sponsor or Administrator property or service. Any person who supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these Official Rules in an attempt to obtain any prize will forfeit any prize won and may be prosecuted to the full extent of the law. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**9. Limitations of Liability:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Reward Program participants/Sweepstakes entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or

network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Reward Program participant/Sweepstakes entrant's participation in the Promotion or receipt or use or misuse of any prize or (7) late, lost, misdirected, illegible, incomplete or mutilated entries or for theft, destruction or unauthorized access to, or alteration of entries. If for any reason an Sweepstakes entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Sweepstakes entrant's sole remedy is another entry in the Promotion, if it is possible. In connection with the Sweepstakes, no more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes in the Sweepstakes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

**10. Disputes:** You agree that any claim or dispute at law or equity that has arisen or may arise relating in any way to or arising out of the Promotion or the Official Rules, will be resolved in accordance with the provisions set forth in this Dispute Resolution section. Please read this section carefully. It affects your rights and will have a substantial impact on how claims you and we have against each other are resolved.

You agree that whenever you have a disagreement with Administrator or Sponsor arising out of, connected to, or in any way related to the Promotion or the Official Rules, you will send a written notice to the Administrator ("Demand"). You agree that the requirements of this Dispute Resolution section will apply even to disagreements that may have arisen before you accepted these Official Rules. You must send the Demand to the following address (the "Notice Address"): Legal Department, Merkle Inc., 3000 Town Center, Suite 2100, Southfield, MI 48075. You agree that you will not take any legal action, including filing a lawsuit or demanding arbitration, until 10 business days after you send a Demand. If the disagreement stated in the Demand is not resolved to your satisfaction within 10 business days after it is received, and you intend on taking legal action, you agree that you will file a demand for arbitration with the American Arbitration Association (the "Arbitrator"). This arbitration provision limits the ability of you, Administrator, and Sponsor to litigate claims in court and you, Administrator, and Sponsor each agree to waive your respective rights to a jury trial or a state or federal judge. You agree that you will not file any lawsuit against Administrator or Sponsor in any state or federal court. You agree that if you do sue in state or federal court, and Administrator or Sponsor brings a successful motion to compel arbitration, you must pay all fees and costs incurred by Administrator and Sponsor in court, including reasonable attorney's fees. For any such filing of a demand for arbitration, you must effect proper service under the rules of the Arbitrator and notice to the Notice Address may not be sufficient. If, for any reason, the American Arbitration Association is unable to conduct the arbitration, you may file your case with any national arbitration company. The Arbitrator shall apply the AAA Consumer Arbitration Rules effective September 1, 2014 (as may be amended) and as modified by the agreement to arbitrate in this Dispute Resolution section. You agree that the Arbitrator will have sole and exclusive jurisdiction over any dispute you have with Administrator or Sponsor. The Federal Arbitration Act allows for the enforcement of arbitration agreements and governs the interpretation and enforcement of the agreement to arbitrate.

You agree that you will not file a class action or collective action against Administrator or Sponsor, and that you will not participate in a class action or collective action against them. You agree that you will not join your claims to those of any other person. Notwithstanding any other provision in the Official Rules, if this class action waiver is invalidated, then the agreement to arbitrate is null and void, as though it were never entered into, and any arbitration dispute at that time will be dismissed without prejudice and may be refiled in a court. Under no circumstances do you, Administrator, or Sponsor agree to class or collective procedures in arbitration or the joinder of claims in arbitration. Administrator and Sponsor agree that we will submit all disputes with you to arbitration before the Arbitrator.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Sweepstakes entrant, Administrator, and Sponsor in connection with the Promotion, or any claim or dispute that has arisen or may arise between you,

Administrator and Sponsor, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules. The place of arbitration shall be Oakland County, Michigan. This arbitration provision shall survive conclusion, modification or termination of the Promotion and suspension, revocation, closure, modification, or amendments to the Official Rules, and any aspect of the relationship of the parties relating to or arising from participation in the Promotion.

**11. Participant/Entrant's Personal Information:** Information collected from participation is subject to Sponsor's Privacy Policy <http://www.generalmills.com/en/Company/privacy-policies/privacy-policy-US>.

**12. Winner List:** For of the name of the Sweepstakes winners, visit <https://bit.ly/38Tlat0>. The winner list will be posted after winner confirmation is complete.

**13. Miscellaneous:** The names of individuals, groups, companies, products and services mentioned herein, and any corresponding likenesses, logos and images thereof reproduced herein, have been used for identification purposes only and may be the copyrighted properties and trademarks of their respective owners. The mention of any individual, group or company, or the inclusion of a product or service as a prize, does not imply any association with or endorsement by such individual, group or company or the manufacturer or distributor of such product or service and, except as otherwise indicated, no association or endorsement is intended or should be inferred. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. For Reward Program participant/Sweepstakes entrants, to the extent there is a conflict between these Official Rules and any terms of use or other agreement posted on the website, these Official Rules control.
